### **NGIM NA:**

Hih sum tawh kisai huhna pen guarantor te in zatui kibawl na ding hi ta leh cidamna tawh kisai sepsak khat peuh a om ciang in a sumpiak ding a neih kei leh a hi zong in insurance a kici sum khol cih te pan a piak ding a neih kei leh hih sum tawh kisai huhna pen kizang ding hi. Hih sum tawh kisai huh na zah ding khiap zia leh khat zia te pen Saint Francis i cidam na tawh kisai thunei te in khat leh khat din mun en in a khen sat na a tuam thu om a hih kei leh hih thukhun ki palsat lo ding hi. Hih thukhun man tak leh hoih tak a zuih na in ka ngim na pi uh a hi “**Sepna khempeuh ah Topa Zeisu om pih na leh a cina damsak nasep nate khang sak sem sem ding**” cih pen tangtung sak ding hi. **Hih thukhun pen Siahpiak tawh kisai Kumpi Thukhun tawh a kituak ding in a kigelh a hihi.**

Hih Sum tawh kisai Huhna Thukhun (“Thukhun”) pen Saint Francis Cidam na tawh Kisai khem peuh ahi Azom A a kigelh (“SFHS” a kici te leh “A kizom/kisai”) khempeuh in a zuih ding thukhun a hi hi. A tuam deuh dinmun a hih kei nak leh, hih thukhun pen “SFHS Sum tawh kisai Huhna Thukhun i huam leh huam loh” cih na ah a ki lak khia SFHS i sumpiak ding sung ah a mau nasep a kihel lo a hi siahuan/siamah te leh a dang zatui tawh kisai a pia te, apoi mawh hun a mawhpuak a la sia/siamah te, ihmum/khuaphawk loh za tawh kisai sia/siamah te, datman sia/siamah te, zato sung a cina khoi sia/siamah te, natna tuamtuam a vel sia/siamah cih te leh a dang dang te tawh kisai lo hi. Hih thukhun tawh kizui in SFHS pan tua sia/siamah te leh a dang dang sepsak a nei te sepsak na tha piak ding mawhpuak nei lo hi.

**Siauh zia ding tawh kisai:** Saint Francis Cidamna tawh kisai setvan sung ah guarantor i sum lutz ah leh a inn kuan pha zah cih te a kisam teng setvan tawh line pan a hih kei leh laidal tawh guarantor a hih kei leh ama tang in khat peuh in dotna te dawng thei hi. SFHS pan thunei te in tua siauh nate khat khit khat nasep, innkuan pha zah leh mat kipia zah cih te tung tawn in sit tel in khen sat ding hi.

**Leiba Loh lo:** Sumpiak hun ding a a kipia nai lo leiba zah leh sum huhna a ngah thei ding hina pi in sum piak zawh loh na a hang tawh kisai bang mah ciap teh na omlo te pen leiba mah in ki ciam teh ding hi.
