## **Executive Summary**

#### About Saint Francis Health System, Inc.

Saint Francis Health System, Inc. (Saint Francis) is a Catholic, not-for-profit health system wholly owned and operated in Tulsa. Oklahoma whose mission is to extend the presence and healing ministry of Christ to all who seek its services. The health system is anchored by Saint Francis Hospital, Inc., a 1,100-bed tertiary center, which includes a 162-bed Children's Hospital with the region's only level IV neonatal intensive care unit, a 168-bed heart hospital and Tulsa's leading trauma and emergency center. Also part of the health system are Saint Francis Hospital South, LLC, Saint Francis Hospital Muskogee, Inc., Saint Francis Hospital Vinita, Inc., Saint Francis Glenpool and Laureate Psychiatric Clinic and Hospital, Inc.—a 90-bed private, psychiatric facility. Additionally, Saint Francis employs over 350 physicians and 121 advanced practice providers through Warren Clinic, Inc., which serves the region with over 90 locations throughout eastern Oklahoma.

#### Purpose of Implementation Strategy

This implementation strategy has been prepared in order to comply with federal tax law requirements set forth under Internal Revenue Code section 501(r) requiring hospital facilities owned and operated by an organization described in Code section 501(c) to conduct a community health needs assessment (CHNA) at least once every three years and adopt an implementation strategy to meet the community health needs identified through the community health needs assessment.

Saint Francis Hospital, Inc., Saint Francis Hospital South, LLC, Saint Francis Hospital Muskogee, Inc., Saint Francis Hospital Vinita, Inc. and Laureate Psychiatric Clinic and Hospital, Inc. are facilities that share the same service area and for which all community benefit functions are centralized at the health system level. Health system staff completed the CHNA and subsequent implementation strategy in 2019. The CHNA and implementation strategy were adopted by the Saint Francis Health System Board of Directors on April 23, 2019 and will continue to guide the health system's community benefit activities and partnerships until a new comprehensive CHNA process is conducted in 2022.

Increase health education and preventative care provided in the community setting through partnership with community organizations, faith-based organizations and other institutions

#### **ACTIONS TO BE TAKEN:**

Develop stronger linkages with other Catholic organizations (i.e. Catholic Charities, parishes) in the Tulsa Diocese (SP 1.2.2).

- Demonstrate greater collaboration with county health departments as it relates to seasonal flu shots, pneumonia vaccinations, nutritional education, prenatal care, behavioral health and substance use disorder management (SP 1.2.3).
- Continue to collaborate with community organizations that work to increase access to care for vulnerable community populations.

- Expand E-visits pilot at Warren Clinic, Inc. locations to include video visits (SP 2.2.2).
- Build a system-wide healthy employee program to include video visits (SP 2.2.3).

- Fulfill recruitment targets for nurses and physicians at Warren Clinic, Inc. (SP 3.1.1, 3.1.2, 7.1.1).
- Fulfill recruitment targets for primary care and emergency physicians at Warren Clinic, Inc. facilities in Glenpool, Owasso, Sand Springs and Claremore (SP 3.2.1).
- Fulfill recruitment targets for specialists in key service lines (such as cardiology, neurology and others) serving rural areas (SP 3.2.2).
- Educate nurse practitioners, physicians assistants and care coordination nurses in telehealth protocols (SP 4.1.2).
- Invest and build relationships with local nursing and medical schools (SP 7.1.2, 7.1.3).

Collaborate with regional physicians on building a continuum of care for behavioral health in Muskogee and Vinita (SP 2.3.2).

#### **MEASURES TO EVALUATE IMPACT:**

- Assessments completed to evaluate the current continuum of care for behavioral health in Muskogee and Vinita
- Opportunities identified to address gaps in the continuum of care
- Intensive outpatient program visits provided to rural populations in the Vinita and Muskogee areas

## BEHAVIORAL HEALTH INTEGRATION WITH PRIMARY CARE AND EMERGENCY SERVICES (SP 4.2)

#### **ANTICIPATED IMPACT OF STRATEGY:**

Coordinate general and behavioral health to improve outcomes, reduce use of emergency and inpatient care, and decrease care costs

#### **ACTIONS TO BE TAKEN:**

- Coordinate clinical direction of Saint Francis behavioral health service lines under Laureate Psychiatric Clinic and Hospital, Inc. (Laureate) (SP 4.2.1).
- Explore the feasibility of monitoring or refining the existing social worker model and consider expansion of the "embedded" model in other primary care practices in Tulsa, Muskogee and Vinita (SP 4.2.2).
- Explore Laureate on-site coverage to include the Saint Francis Hospital Emergency Room/Trauma Center and Vinita medical practices (SP 4.2.3).
- Explore the possibility for a pain rehabilitation program at Laureate (SP 4.2.4).

#### **MEASURES TO EVALUATE IMPACT:**

- Service line leader and/or task force identified to facilitate coordination of behavioral health under Laureate
- Appropriate metrics established and tracked to measure clinical quality and patient safety at Laureate, such as readmission rates
- Completed feasibility assessment for existing social worker model and expansion to other primary care practices
- Appropriate metrics established and tracked to support future behavioral health and primary care integration, such as number of behavioral health patients managed within primary care practices
- Completed feasibility assessments for emergency/ trauma coverage, Vinita medical practices and pain rehabilitation program

Increase access to high-quality disease prevention and management for chronic diseases and stroke

#### **ACTIONS TO BE TAKEN:**

Develop outreach programs for service lines that contribute significantly to chronic disease, such as cardiology, stroke/ neurology and oncology (SP 2.1.3).

#### **MEASURES TO EVALUATE IMPACT:**

- Appropriate metrics established and tracked to evaluate outreach programs, such as number of screenings or education classes offered
- Number of outreach programs developed
- Number of partnerships and collaborations addressing nonclinical determinants of health affecting chronic disease, such as nutrition

- Number of patients enrolled in the oncology care model
- Appropriate performance metrics established for reporting by the Centers for Medicare & Medicaid Services
- Assessment of potential linkages between Muskogee and Tulsa oncologists

#### **XAVIER CLINIC (SP 1.3)**

#### **ANTICIPATED IMPACT OF STRATEGY:**

Provide access to free primary care, prenatal healthcare, and other services for uninsured or medically underserved populations (including a significant Spanish-speaking population)

#### **ACTIONS TO BE TAKEN:**

- Continue financial, clinical, and administrative support of the Xavier Clinic to deliver free health care services to vulnerable populations.
- Investigate the feasibility of an addition Xavier Clinic location in Muskogee (SP 1.3.2).

#### **MEASURES TO EVALUATE IMPACT:**

- Number of medical visits and deliveries provided by the Xavier Clinic
- Amount of financial support provided to the Xavier Clinic
- Feasibility assessment completed for the Xavier Clinic

- Support uninsured or underinsured populations by connecting them to available insurance coverage and benefits.
- Continue to provide financial assistance and charity care through funds designated for patient aid.

- Number of resources available to support identification of available coverage and aid in enrollment
- Number of individuals enrolled by financial counselors or eligibility specialists
- Number of individuals receiving financial assistance
